Description of Course

This course is an introduction to the methods of empirical science as they apply to psychology. The objective is to provide students with the rudimentary skills needed to understand original research reports and to design and execute psychological research. Specific topics are centered on the four types of validity and include the nature of data and error, experimental design and control, correlational methods, and some advanced topics. This approach emphasizes both the frequent conflict between the four types of validity and the cumulative nature of empirical science, showing how studies often build upon one another and how a series of studies successively constrain the possible answers to theoretical questions. Grades are based on several mid-term exams, a final exam, and many homework assignments. Lectures are given by the professor; discussion sections are led by the TAs.

Grading System

Grades will not be curved against other students in the course, but the difficulty of the exams will be designed such that the distribution of grades approximates that suggested by the College of Liberal Arts and Sciences: 18% As, 36% Bs, 39% Cs, 5% Ds, and 2% Fs. Any student earning at least 90% (without rounding) of all of the available points will receive at least an A-; 80% guarantees a B- or better; 70% gets a C- or better; and at least 60% of the available points must be earned to pass the course (with a D- or better). While +/- grading will be used, to be consistent with the policies of the College, it should be noted that a grade of A+ will only be given in extraordinary situations.

Exams, Assignments, and Percentage of Final Grade

A large majority of the final grade is determined by exams concerning material from the readings and lecture. The remainder is determined by assignments that are due in section.

Exams (85% of total). There will be three, non-cumulative, mid-term exams (see below for dates and values) and one, semi-cumulative, final exam. (Approximately two thirds of the final will concern things that came up in an earlier part of the course.) These exams will cover material from the text and lecture, using definitions, multiple-choice, and short-answer questions.

Other assignments (15% of total). There will be a variety of homework assignments given in section. The due-dates and values of these assignments will be described on a separate syllabus to be distributed in section during the second week of the semester.

Other Course Policies

Course attendance. Attendance in lecture is strongly suggested, but not required. (There is no need to contact the instructor with regard to missed lectures.) Students are responsible for all material presented in lecture even if they miss the lecture for a very good reason. Attendance in "section" meetings is required and attendance will be taken. Students should contact their section TA as soon as possible (in advance being preferred) with regard to missed section meetings. There will be a penalty (of 1% of final grade per class) for more than one unexcused absence from section.

Participation in class discussions. Students are expected to participate in the "section" meetings. Asking questions in lecture is encouraged, but not required.

Timely completion of assignments. Late assignments for section will be penalized (10% of their value per day) unless a documented excuse is provided.

Honors designation. Contact the instructor before the first exam.
